Sherose Island Sewage Treatment Plant

The Clerk informed members by way of memo dated September 19, 2012 that SNC Lavalin had identified two viable alternatives for sewage treatment at Sherose Island:

- A. Routing sewage to the plant at Brass Hill.
- B. Installation of a recirculating filter system.

The preferred option is the recirculating filter system due to its low cost of operation, its lower cost of construction, and the minimum technical requirements for operation.
