CORRESPONDENCE

Municipal and Village Code of Conduct Regulations

Correspondence has been received from the Minister of Municipal Affairs advising that work is commencing on Municipal and Village Code of Conduct Regulations. In order to develop the regulations related to municipal codes of conduct, they have chosen to establish a Code of Conduct Working Group. This group has a mandate of developing recommendations on the content to be included in the regulations. Once the group has developed their recommendations, DMAH will consult with all municipalities and villages on the proposal.

Renegotiation of Memorandum of Understanding with Municipalities

Correspondence has been received from the Nova Scotia Federation of Municipalities in response to our letter of November 29, 2021, regarding the renegotiation of the Memorandum of Understanding with Municipalities. The letter advised that the Board of Directors will be striking a subcommittee to map out this process. The letter further advised that they will keep us informed of process advances.

CROSSWALK AND STREET LIGHT

Reference was made to a recent accident in Barrington Passage. Residents have requested that the previous request for a crosswalk in that area be reconsidered. It was agreed that information be pulled on this matter and it be placed on the January 10th Committee of the Whole Council Meeting agenda for discussion.

It was noted that it is extremely dark in that area and it has been suggested that additional street lights be installed to light the roadway. This matter has been discussed with the CAO and the request is currently being explored.

COMMUNITY NAME CHANGES

It was reported that Service Nova Scotia and Internal Services has sent surveys to residents of Shelburne County, requesting selections for replacement names for Negro Harbour, Cape Negro (community), Cape Negro Island and Cape Negro (point on the island). The survey is dated November 26, 2021 and as of today's date many residents have not yet received it. The deadline to respond is December 31, 2021.

Resolution C211204

Being duly moved and seconded that a letter be sent to Service Nova Scotia and Internal Services, requesting the survey deadline be extended to February 28, 2022, giving residents additional time to respond to the survey to select new names, as many residents have not yet received the survey.

The virtual tree lighting ceremony took place on Friday, November 26. We once again had local musicians to entertain us and Santa to read local letters. Despite having to have a virtual event again this year, the overall event was successful. Recreation Programming

The Dept. attended a session by Engage NS and Communities, Culture, Tourism and Heritage who had previously presented the data associated with the 2019 **Quality of Life** Survey. This session was to look at the local data for Yarmouth & Shelburne Counties as it pertains to access to recreation being a major factor in positive assessment of wellbeing in Nova Scotia. The session was held on December 6th in Barrington and engaged those primarily working in recreation in Yarmouth and Shelburne but also at a provincial level through the regional office of CCTH, Sport NS and Recreation Nova Scotia.

The Dept. continues to fine-tune their use of the **facility booking and registration software**. There was a major upgrade recently and it will be of incredible value to how we use it, especially come summer.

A **Reindeer Dash**, held virtually, will take place at some point this month and will ask people to share their 2k and 5k routes on the Dept.'s Facebook event page. Each participant will be given a medal for participating. Joel will also share some running routes around the community so runners can try different routes.

The **Fall Punch Card Challenge** continues. It started on November 4th and will end on December 20th. There are 8 punch cards scattered along the Municipality. This activity promotes people to visit different "hidden gems" in the community.

Strategic Planning

As Council is aware, for the past 3 months we have been working on our new strategic plan. We've held three sessions so far, which have included looking at our strengths and weaknesses, reviewing our current mission and vision and developing a list of goals and objectives for the next few years. Building Permits & By-Law Enforcement

From November 15 to December 5, 9 permits were issued with a total dollar value of \$195,000. This is a \$284,200 decrease compared to the same period last year. 57 building inspections were carried out along with 4 fire inspections and 6 re-inspections.

During this period, 2 new civic numbers were issued, and 22 households and businesses were visited.

We received 4 new subdivision applications and completed 1 preliminary subdivision. This leaves us with 5 preliminary open subdivision files that we continue to work on.

During this period, we receive 1 new complaint, but it was quickly resolved as it turned out to be a Nova Scotia Department of Public Works issue. We have no outstanding complaints.

Fire Services & Emergency Management

There continues to be no COVID-19 related staffing issues for the fire departments, and they continue to monitor the status of their membership and communicate that information to the Fire Services Coordinator.

The Level 1 training course has wrapped up other than for the fire suppression course which will take place in the Spring.

On the equipment front, IBPFD has sold tanker 34 to the Harbour Fire Department and are currently in the planning stages for a new rescue truck. In addition, WHSH has received their new extrication combi tool which was funded by Farm Credit Canada's AgriSpirit Fund.
