Committee of the Whole Council –April 8, 2019

Community Forests Shelburne County – Clear Cutting

It is recommended to Council that we support the request received from Timothy Gillespie for Community Forests | Shelburne County and that a letter be sent to the Minister of Lands and Forestry requesting him to meet with representatives of this group to hear their concerns.

Yarmouth Hospital Foundation – Spring Gala

It is recommended to Council that the Municipality sponsor a table of eight (8) at the Yarmouth Hospital Foundation Spring Gala by making a donation of \$1,200.00 and that the seats at the table be resold to the public at the price of \$150.00 each in order to raise additional funds for the foundation.

MPAL – Memorandum of Understanding April 1, 2019 – March 31, 2024

It is recommended to Council that the Municipality enter into the Memorandum of Understanding for the Municipal Physical Activity Leadership Program for the next 5 year period commencing April 1, 2019.

Request from SWRCAC for Free Use of Arena For Fundraiser

It is recommended to Council that the request of the SWRCAC for free use of the arena to hold a fundraiser yard sale on Monday May 20, 2019, (or an alternate date) be approved subject to availability of the arena.

Guarantee Resolution Re: BPLTVFD – Firefighting Equipment

It is recommended to Council that the following resolution be approved:

WHEREAS the Barrington Port La Tour Fire Department is registered with the Municipality of The District of Barrington;

AND WHEREAS the Barrington Port La Tour Fire Department has determined to borrow the aggregate principal amount of Two Hundred and Sixty-Five Thousand Dollars (\$265,000) for the purpose of firefighting equipment;

AND WHEREAS the Barrington Port La Tour Fire Department has requested a municipality to guarantee the said borrowing;

AND WHEREAS Section 294(6) of the Municipal Government Act provides that a municipality may grant or lend money to, or guarantee a loan for, a registered fire department for operating or capital purposes;

AND WHEREAS Section 88(3) of the Municipal Government Act provides that no guarantee of a borrowing by a municipality shall have effect unless the Minister of Municipal Affairs has approved of the proposed borrowing or debenture and of the proposed guarantee;

BE IT THEREFORE RESOLVED

THAT the Municipality of the District of Barrington does hereby approve the borrowing by the Barrington Port La Tour Fire Department of Two Hundred and Sixty-Five Thousand Dollars (\$265,000) for the purpose set out above;

THAT subject to the approval of the Minister of Municipal Affairs of the guarantee, the Municipality unconditionally guarantee repayment of the principal and interest of the borrowing so made;

THAT upon the issue of the debentures, the Warden and CAO of the Municipality do sign the guarantee attached to each of the debentures and affix thereto the corporate seal of the Municipality.
