The centre has hosted weekly Seniors Lunches every Thursday now for the past 5years.A full healthy meal is served while 80-100 seniors get to socialize with friends and family and are entertained. Full breakfasts are served every second week. Special dinners are put on by the centre to raise much needed funds to keep the facility open. The centre has a full service/fully equiped Commercial Kitchen. The centre offers a venue for Wedding Parties, Anniversary Parties, Birthday Parties, Funeral Receptions, Woods Harbour Days, Elections Canada Polling Station, Company General Meetings/ Dinner (Acadian Seafoods, Local Fish Dealers. etc) , Hosted an outside 2020 ERMES Elementary School graduation, Kitchen Parties, Municipal Firemans Awards and Dinner, Easter, Halloween, Christmas, New Years Events, Inside Yards Sales/ Craft Shows, Community Dart Competitions and many many other special events..

Once a month many of the residents of Bay Side Home are bought to the weekly Seniors Lunch. Special table arrangements are made to accomodate the residents and full service is provided whereby the meals are served directly to their table...Also voluteer staff take meals those seniors that cannot make their way to the kitchen to pick up there buffet style meal. Everyone at the WHCC are volunteers. There are no paid staff. The facility is kept clean by the volunteers as there is no money in the budget for cleaners...
