At present we have a command trailer and a logistics trailer that are outfitted with all the equipment needed to perform our duties as a search organization and be a mobile EMO command post in civic emergencies. The vehicle that tows one of the trailers is now 22 years old and needs replacing. We have been planning for this eventuality for the past several years and have managed to fund raise and save \$30,000 towards this purchase.
