NS Nature Trust Request Re: Swaine's Road Bog

In August, representatives of the Nova Scotia Nature Trust provided a power point presentation to the Committee of the Whole Council. During that presentation it was reported that NS Nature Trust has conservation lands in the Municipality at Bon Portage Island, Crow Neck Beach, East Baccaro and Purgatory Point, Blanche. They advised that Swaine's Road and Port LaTour bogs are both nationally significant due to the large concentration of the endangered Thread-leaved Sundew plant. Nature Trust is interested in entering into a conservation easement with the Municipality for these two bogs to ensure the continued conservation of the land and protection of the endangered species.

During discussion of this matter it was noted that there has been no significant change in use of this property. The property appears to be used appropriately and respectfully and is mainly used for hunting and recreational activity along the trail.

**PUBLIC HEARING
PROPOSED AMENDMENTS TO
THE MUNICIPAL PLANNING STRATEGY AND LAND USE BY-LAW
RE: CANNABIS PRODUCTION AND PROCESSING USES**

September 23, 2019

The Public Hearing was called to order by the Warden at 7:30 p.m., in the Council Chambers, in the Administrative Centre, in Barrington, N.S., with the following members present:

The Warden informed members that the Public Hearing was being held this evening to receive public input regarding proposed amendments to the Municipal Planning Strategy and Land Use By-law as it relates to Cannabis Production and Processing Uses.

The Development Officer was asked to explain the proposed amendments.

He reported that these types of uses currently fall under the Agriculture Section of the MPS and LUB. Proposed amendments will strengthen controls by identifying zones where cannabis production and processing uses can take place and will also establish a setback requirement of 200 feet. These amendments will allow cannabis production and processing uses in the Business Park and Rural Development zones only and must be done by Development Agreement.

Deputy Warden Crook, Chair of the Planning Advisory Committee, informed members that concerns expressed at the Public Participation Meeting held August 22, 2019, mostly related to odour.

It was noted that this type of operation is subject to a variety of federal and provincial regulations.

These amendments are being proposed for the protection of our residents and to give clearer direction to developers.

It was noted that required advertisements were placed in the Vanguard Newspaper and on social media notifying the public of the Public Hearing. Notification was also given to adjacent municipal units.

No verbal or written presentations were received from the public.
